When you submit your membership application, you are required to accept and abide by the following membership agreement, which comes into effect when your membership is approved by the **Albany Pride Inc.** committee.

## **Membership Categories**

- General Membership: \$30 (full member voting rights at AGM).
- General Membership Concession: \$10 (full member voting rights at AGM).
- Corporate Membership Associate Members: \$300 (not eligible to vote at AGM).
- Under 15 Associate Members: Free (not eligible to vote at AGM).

### **Member Benefits**

#### **General Members** will receive the following benefits:

- Your membership fees for Albany Pride Inc. help fund our mission and to meet our charitable objectives, such as funding our mental health groups, social networking events, information and education resources, and our annual Albany Pride Festival.
- If you are over the age of fifteen (15), you are eligible to vote in our Annual General Meeting (AGM);
- You are encouraged to register as a volunteer to utilise your skills within the organisation and are eligible to nominate for a position on the Albany Pride Inc. Committee (See: Albany Pride Inc. Constitution for more details).

### Membership Dues

Membership applications will be approved by the **Albany Pride Inc.** Committee, and applicants will receive a confirmation of the outcome of their application within 30 days.

- Corporate Membership: \$300 (not eligible to vote at AGM).
- Under 15: associate members (not eligible to vote at AGM).

The effective term of your membership shall begin on the date when the annual membership fee is paid in full and will commence after the **Albany Pride Inc.** Committee has approved the membership application. Memberships will end and be due for renewal on the exact date the following year.

## Responsibilities of all Members

As a member of Albany Pride Inc., you will:

- Treat all members and attendees to our events with respect. Abusive, threatening, or violent behaviour cannot and will not be tolerated and will result in your membership being terminated.
- Recognise the importance of respecting members and attendees' privacy and confidentiality. For this reason, you will not disclose any personal information gained through membership, or by attending groups or events. This includes not sharing a member's or attendee's name, sexual orientation, gender identity, trans or intersex status, attendance details at the support groups or events, membership status, relationship status etc.

Please Note: Albany Pride Inc. has many out and proud LGBTQIA+ members and attendees, however there are many members and attendees who may be questioning their sexual orientation or gender identity or may only be out to a select group of people, and not at work or the wider community, or in a position where they are unable to disclose their sexual orientation or gender identity due to risks of safety. Breaches of Privacy and confidentiality will result in termination of your membership.

- You will endeavour to respect member's and attendee's pronouns, preferred names, and use gender inclusive language.
- You will ensure that you are respectful in all your communications with other members and attendees. You will endeavour not to ask members or attendees inappropriate questions, such as questions about gender identity, a person's trans or intersex status, questions about bodily autonomy or medical history (including surgical procedures), or sexual orientation or sexual experiences.

Please Note: Albany Pride Inc. values diversity and inclusion and endeavours to provide a safe space for everyone in our community. We support people from all walks of life, including people living with a disability, and people with a lived experience of mental health. Occasionally, any person may ask an inappropriate question or comment, or express unwanted attraction to other members or attendees which may make others feel uncomfortable. If you're ever in this situation please contact Albany Pride Inc. as mentioned above.

You will abide by the policies and procedures of the organisation and you will keep up to date
with relevant information provided by Albany Pride Inc. in relation to policies and procedures,
membership, and the general running of the organisation, as updates occur regularly.

This includes not sharing member's or attendee's name, sexual orientation, gender identity, trans or intersex status, attendance details at the support groups or events, membership status, relationship status etc.
